## 1. Subject of the Contract.

1.1. Subject of the Contract is presenting 088 Toll Free service by “AvirTel” to “User”. The following Toll Free Numbers can be assigned to the “User” based on availability:

## 2. Term of the Contract.

2.1. Contract becomes effective for each year after it is signed by both Parties.

## 3. Responsibilities of the Parties

- 3.1. “AvirTel” is responsible to provide “User” with 088 Toll Free Service.
- 3.2. The obligation of the “User” is to make any and all payments properly on time.

## 4. Terms of payment.

4.1. User makes payments on the basis of following tariffs:

4.2. Payments are made on AZN.

4.3. “User” makes payment for all incoming calls within 3 (three) days after receiving invoice according to the payments rules.

4.5. Postponing payments by “User” will be cause for “AvirTel” to stop serving.

4.6. In case of termination of the Contract monthly fee is not returnable and the number can be transferred to another customer.

4.7. Toll Free number is the property of AvirTel.

**5. Termination of the Contract.**

5.1. The Contract can be terminated with the initiative of one party only by sending written notification to other side 30 days before cancellation.

5.2. The Contract will be renewed with the same terms and conditions automatically for another year if non of the Party send notification to another side about the termination of existing Contract 30 (thirty) calendar days before the date of termination.

**6. Force-Majuro.**

6.1. None of the sides is responsible for abolition of contract at the result of war or revolution, national or local state of emergency, fire, thunderbolt explosion, flood and other relevant events.

**7. The leading laws and solution of conflicts.**

7.1. Contract should be in accordance with the legislation of Republic of Azerbaijan.

7.2. Any conflict between the Parties should be solved by the agreement of the sides. If any contradiction and misunderstanding between parties cannot be resolved on the basis of negotiation, then problem will be solved in relevant Courts of Republic of Azerbaijan.

**8. General terms.**

8.1. According to the subject of the contract this treaty consists of the present agreement between the parties and/or identifies all previous negotiations and agreements in written form.

8.2. The contract is signed in 2 copies and one of copies will be kept at “AvirTel”, another at “User”.
